

Membership Meeting Highlights – July 15

Meeting brought to order at 7:56 p.m. following the extremely informative presentation by Dr. Lisa Woodside, from Ready To Go Veterinary Rehabilitation.

Carolyn Pearson (Secretary). The March Meeting minutes were approved as published.

Ed Herdes (First Vice-President) reported that mat cleaning is tentatively scheduled for Monday, September 21st or September 28th. Information will be announced once the date is confirmed with the fairgrounds.

Wendy Waddick (Second Vice-President) reported that the following programs have been set up for the remaining 2015 Membership meetings.

- September 16th – Dr. Kimberly Hsu, from Eye Care for Animals, will do a follow-up on the program presented on November 19, 2014, by Dr. Annora Sheehan Gaerig.
- November 4th - Loretta Lazzara will discuss the new AKC obedience rule changes which go into effect in December 1, 2015.

Phil Nuger (Treasurer) reported that he is still getting into the swing of things. Donna

stated that the YTD income/expense reports should be presented at each membership meeting. In response to Kathie Spang's question, it was agreed that an audit should occur and will be discussed at the August Board meeting.

Will Short (Director of Training) stated that he is concerned that individuals are not paying attention to the "No Left Turn" signs. When arriving to the fairgrounds from the south on Randall Road, there is a "No Left Turn" sign. Additionally, even though the sign is no longer present, cars should not cross the double-yellow lines when going North on Randall Road from the fairgrounds. Barb Runkle stated that as an instructor, she does mention it to her students. Anyone leaving the fairgrounds going North on Randall Road are doing it at their own risk.

Cindy Pakenas (Obedience Trial Chairperson) stated that Sue MacPherson has graciously agreed to provide food for the judges and stewards for the 2015 obedience trial as the Kitchen Chair. Anyone who would like to volunteer to assist Sue either on Saturday, Sunday or both should contact Sue

Additionally, it was agreed that classes held in the rings should be slightly modified. The following describes the old and new building layout for the obedience trials.

To address the concerns about the amount of distractions caused by spectators and exhibitors along the side of Ring 5, it was agreed that the buffer gates that traditionally been along the side will be the solid gates.

Cindy also reported that we will host an Obedience “C” match on Saturday afternoon. This will enable exhibitors the opportunity to briefly rent-a-ring to train where they are showing in Sunday for a small fee. Exhibitors wishing to take advantage of the opportunity will be able to sign up starting at 10:00 a.m. on Saturday. The fee is \$10.00 for 8 minutes in the ring. The match will start following the conclusion of the regular classes or 2:00 p.m. whichever is later, and end at 4:30 p.m. Nancy Einwich is the Match “C” Trial Chair and Penny Brcich is the Match “C” Trial Secretary. Cindy encouraged club members to spread the word about the rent-a-ring opportunity.

Donna thanked Barb for stepping in at the last minute. Ed thanked Barb for making the building presentable after the 4-H show on Wednesday, June 24th.

Cathy Fleury (Agility Trial Chairperson)

was not in attendance, however Donna reported that the September Agility Trials will be hosted at the SportsPlex on Dean Street in the future.

David Lewis (Director at Large) reported that the Fox Valley Veterinary Clinic has asked us to do an hour-long agility demonstration on Sunday, August 9th prior to the North Aurora Days Pet Parade at the corner of Route 31 and Butterfield Road. He currently has a couple of volunteers to demonstrate agility, but more would be better. Additionally, help will be needed to set-up and take-down the equipment. Dave stated that the clinic has been recommending us to their clients for many years, and this is a good way to return that kindness. Anybody who is interested should contact Dave by Sunday, July 19th.

Additionally, Dave reported that he is in the process of making some significant changes to the "Members Only" part of the web site to simplify tracking awards eligibility and dues discounts. Look for that to be done in the Fall.
