Congratulations to all of the participants of the FVDTC 2002 fall tracking trial. This trial has been our MOST SUCCESSFUL EVENT EVER, according to Ingrid Hamburger, who has been involved with the trials for a number of years.

High humidity, temperatures in the 90s, and unimaginably ferocious mosquitoes dominated conversations for the entire weekend.

It began on Saturday when judges, Bonnie Kircher and Pam German; along with tracklayers Ed Herdes (FVDTC), Sylvia Schultz (FVDTC), Cindy Pakenas (FVDTC), Diana Ing, Jeff Beatty, Debbie Yagoda, Donna Kircher, and Carol Barsema; and cross-tracklayer, Donna Dodson (FVDTC), went into the fields to plot and walk the tracks that the dogs would scent and handlers would navigate during Sunday's trial. Although a variety of sprays were utilized, including 100% Deet, the mosquitoes attacked with a vengeance. The one-hour post dawn and pre-sunset rule was not known or recognized by the mosquitoes of Burnidge Forest Preserve. The heat, field conditions, and the mosquitoes forced the group to take a few greatly deserved breaks to rest and re-hydrate. (FVDTC), Mary Bradley (FVDTC) and Amber Perri, who came to help on Sunday, were also subjected to the same brutal onslaught as those on Saturday.

The superb teamwork of Bonnie and Pam created tracks with elements that provided a challenging but fair test for each of the teams participating on Sunday. They also did a wonderful job in arranging the tracks. Each track flowed into the next allowing handlers and dogs and judges and tracklayers to move on and off the fields quickly saving time and energy. Since heat was a major factor this was especially important to dogs running their tracks as the temperature of the day rose higher. All tracking was completed by about 11:30 a.m. on Sunday.

Francene spoke to participants regarding the weather and encouraged all to bring provisions to cool the dogs while on and off the fields. On Saturday, it was suggested that we have a small wading pool at the pavilion for the animals. Francene brought a garden hose to fill the pool. Imagine everyone's surprise when it was noted to be a soaker hose and water came streaming out of all the tiny holes. The hose did work well enough to fill the pool. Both of the judges commented on how pleased they were that the handlers provided comfort measures for their dogs on the tracks as appropriately needed. No dogs appeared to have suffered any heat stress during the trial.

Sylvia Schultz, Ingrid Hamburger, and Francene Andresen arranged food and beverages for breakfast and lunch on Saturday and Sunday. Ingrid and Francene brought a number of oscillating fans and citronella candles for use in the pavilion. Saturday was a long day for the crew. The day started at 8:00 a.m. and ended around 4:00 p.m. On Sunday, the judges, tracklayers and committee members arrived at the forest preserve at 5:45 a.m. to begin laying the tracks and setting up for the activities.

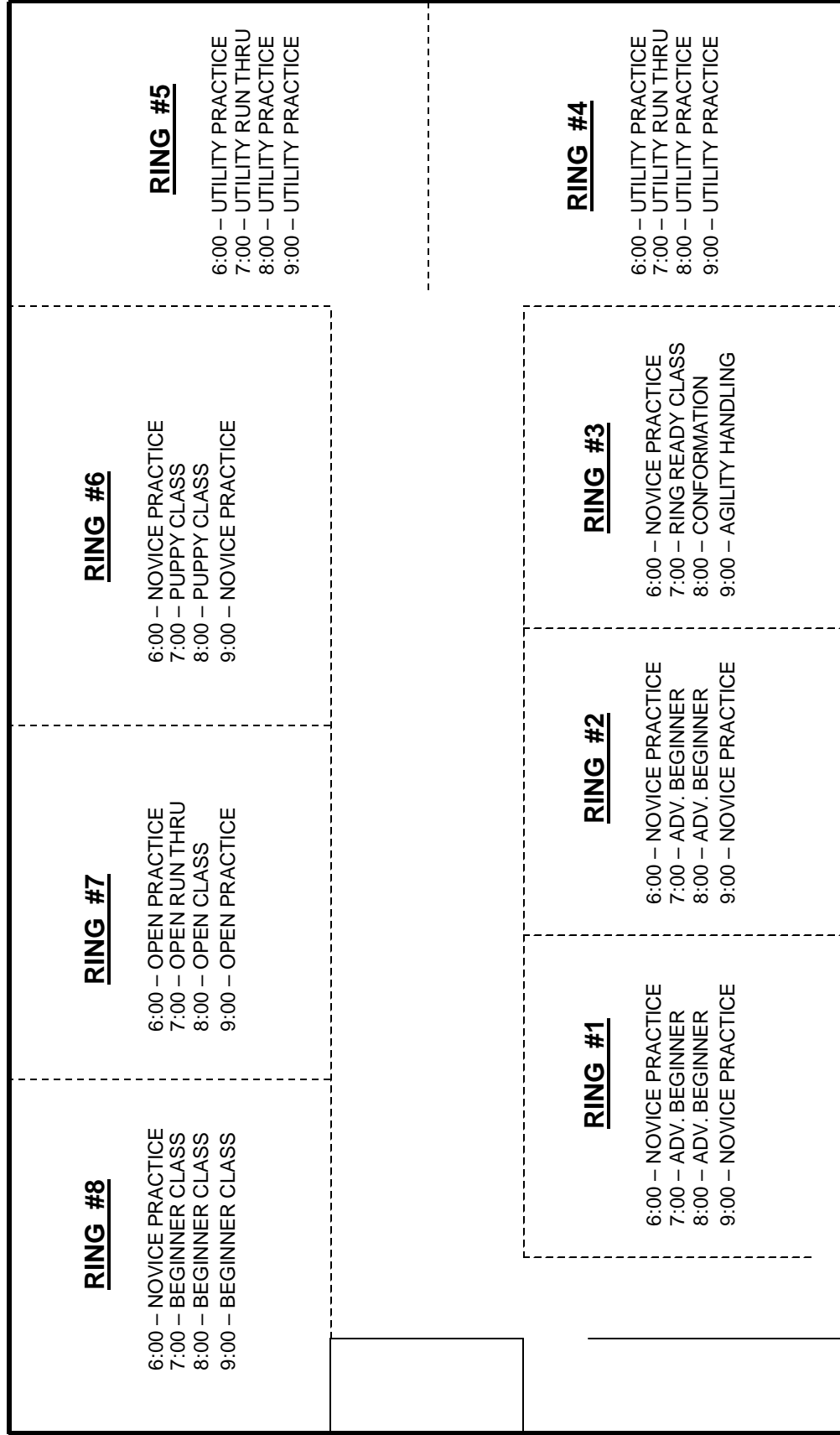

### *Membership Meeting Highlights October 2, 2002*

Meeting brought to order at 7:43 p.m., by Vera Nyberg. President, Tracey Mohr, was at a mandatory out of town business meeting.

Carolyn Pearson (Secretary). The September Meeting minutes were approved as published with the following amend-

ment presented by Will Short. Will Short presented a letter from Kay Weber regarding her comments at the September 4 meeting. Carolyn read the following from Kay's letter:

*At the September membership meeting, I did not state that the only training method that should be used is positive reinforcement. What I did say was that the most common method I see being used at training is positive punishment. Carolyn then asked*

*me to define positive punishment. I stated that positive punishment is the addition of punishment as a consequence of a behavior (even is the dog is given a treat after the punishment). I also gave an example a dog is asked to sit. The dog does not sit, so it is punished. Some examples of punishment would be verbal (yelling), physical (hitting), collar corrections, or a shock.*

*The terms positive punishment, negative punishment, positive reinforcement, negative reinforcement are scientific definitions of consequences when using operant conditioning. Operant and classical conditioning are methods by which all animals (including humans) learn and have been used for centuries. These theories have been scientifically proven and are not subject to individual interpretation or opinion.*

Carolyn thanked Kay for the written explanation. Peggy Sue Seehafer made a motion to accept the minutes as amended. Bill Clarke seconded the motion. The minutes were approved by all. Several items of correspondence were read.

Vera Nyberg (Second Vice-President) reported that she is finalizing the details for the demonstration to be held at the November 6<sup>th</sup> Membership Meeting. Sue Olmos, certified Pet Massage Therapist will present a demonstration of a dog massage. Lane Phelan has graciously agreed to allow her service dog, Beau, be the demo -dog.

## Old Business

- Electronic Training Collar Issue – All envelopes were opened and counted at the meeting. Taffy Wille and Peggy Sue Seehafer verified the signature sheets to the eligible voters list and separated the ballots and signature sheets to maintain anonymity of each voter.

Merry Lee Hritsuk asked that Will Short also be involved in the counting of the ballots. Taffy Wille, Peggy Sue Seehafer and Will Short then counted and presented the results to Vera Nyberg. Carolyn Pearson read the following results.

Taffy Wille reported that after she read the report in the September Waggin' Tales about what Will Short had been told by the Animal House veterinary clinic, she stopped in to get some clarification because Animal House is her vet. In her conversations with the front desk employees and the vet techs, Taffy was told that they would not recommend against any training facility because of the training methods used. When asked by clinic clients, a list of available training classes are provided to the client. The Animal Clinic employees also stated that they do not act as a middleman, should their client express concerns to them about the training classes. The clinics clients are told to go directly to the training class individuals. Taffy stated that she was relieved to hear what their policy was because the Animal House clinic has provided the training club with a significant number of referrals in the past.

Merry Lee Hritsuk stated that she has a signed letter from her vet's office, Countryside Animal Clinic, stating that they would not recommend the training club, if we allowed the use of electronic training collars. Although, she had the letter at the September Membership Meeting, she did not present the letter at the time because she did not have it available to present to Tracey Mohr prior

## Meet Beau - The Dog With the Best Job in the World

He's strutted his service dog skills during demonstrations at schools, corporations, military bases, conventions and expos.

His hobbies include running from window-to-window chasing cats and squirrels, squeezing and shaking his stuffed toys, romping, and posing for photos with the three golden Miller Boyz. He also loves tennis balls and scratches behind the ears that produce that golden smile.

Although Beau's hips met the "no hip dysplasia" requirement of Paws' service dogs, age takes its toll. Signs of arthritis introduced Cosequin DS and Rimadyl into his daily regimen. However, no medication can substitute for loving, knowledgeable hands performing massage therapy.

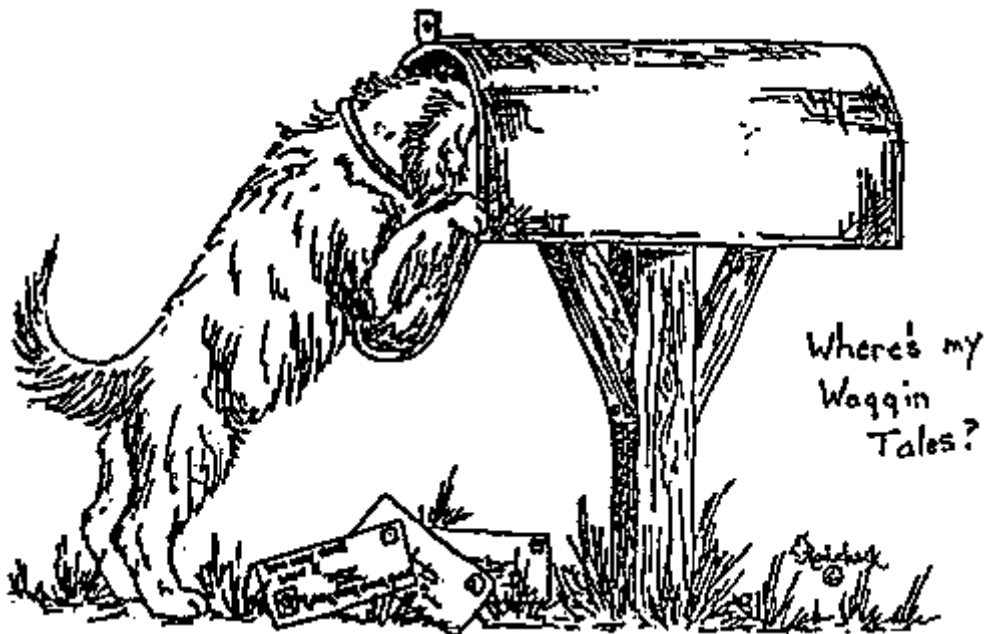
